ORDER

As per the U O cited 1st, a committee was constituted with Dr. E.K. Satheesh, Professor, Department of Commerce & Management, University of Calicut as Co-Ordinator, to formulate the IPR policy of the University. The Committee conducted two meetings on 26-10-2018 and 29-10-2018 in the chamber of Pro-ViceChancellor. The meeting convened on 29-10-2018 discussed about the draft policy formulated by the law Department and made necessary suggestions and include every legal aspects related to the policy.

The Committee convened a meeting on 04-10-2019 and recommended to approve the draft IPR Policy with modifications and resolved to circulate it among all the members for their information. The draft policy was circulated among the members of the IPR cell and a meeting of the Committee members was held on 20-12-2019. The Committee suggested a few more corrections. Dr. E. K. Satheesh, Co-Ordinator, IPR Cell, submitted the revised IPR policy after incorporating the details of "Geographic Index".

As per the U O cited 2nd, the Syndicate in its meeting held on 29-01-2020, vide item no.2020.67* has resolved to defer for detailed study by a Committee with Sri .K K Haneefa as Covenor and Prof. M. M. Narayanan, Adv.Tom. K. Thomas, Dr. M. Manoharan, Sri. A. K. Ramesh Babu as members on the matter of approving the draft IPR policy of the University.

After the detailed study of this committee, it was decided to convene a meeting at the Senate house on 08-01-2021 at 12.00 noon. The committee has recommended to approve IPR policy and also decided to invite the feedback from stakeholders by publishing the same in the university website and place the consolidated feedback of the policy to the academic council. Considering this, the Vice-Chancellor ordered to place the draft IPR policy before the Syndicate.

As per the reference cited 3rd, the Syndicate in its meeting held on 30-01-2021, vide Item.No.2021.65* has approved the draft IPR Policy.

As per the reference cited 4th, the Vice-chancellor has ordered to implement the above resolution of the Syndicate and the resolution of the Syndicate held on 30-01-2021, vide Item.No.2021.65* is thus implemented.
