Second Phase of Election to the Senate of the University of Calicut as per sub sections (1), (6), (7), (8) & (12) under 'Elected Members' of section 17 of the Calicut University Act, 1975 (Act 1975)

**NOTIFICATION**

WHEREAS it has become necessary to reconstitute the Senate of the University of Calicut, in accordance with the provisions of the Calicut University Act, 1975 and in consonance with the direction of Hon'ble High Court of Kerala in WP(C) No. 5858/2023, it is hereby notified that election (Phase II) will be held according to the principle of proportional representation by means of a single transferable vote and in accordance with the procedure laid down in the Calicut University (conduct of elections to various Authorities or Bodies) First Statutes, 1975, to elect:

- (i) Seven Principals elected from among themselves, of whom two shall be from among the Principals of Govt. Colleges, one from among the Principals of Professional Colleges and one from among the Principals of Junior Colleges.
- (ii) Sixteen members elected by the Teachers of Private Colleges from among themselves.
- (iii) One member elected by the members of the Local Authorities of each district in the University area from among themselves.
- (iv) Two members elected by the Registered Trade Unions in the University area designated by Statutes from among their members.
- (v) Ten members elected by the members of the General Council of the University Union from among full-time students, of whom one shall be post-graduate student, one shall be research scholar, one shall be student of Professional Colleges and one shall be a lady student.
