ORDER

1. As per the paper read (1) above, Shri. Salim N, Head of the P.G. Dept. of Public Administration, Rajiv Gandhi Memorial Govt. College, Attappady intimated that their college is offering B.A. in Public Administration from the academic year 2012-13 onwards and the Govt. of Kerala has sanctioned M.A. Public Administration programme in the college, w.e.f 2019-20 academic year. He has pointed out that even though Public Administration has greater importance in the present administrative and academic scenario of Kerala and UG & PG Departments have been constituted for the subject in the college affiliated to this University, a Board of Studies for the subject has not been constituted so far.
2. It was further stated that at present the Board of Studies in Political Science is dealing with the academic matters including the preparation and revision of syllabus related with Public Administration and no member from the discipline of Public Administration is included in this Board. Hence, he has requested to constitute a Board of Studies in Public Administration for PG and UG separately. After having considered the request, the Vice-Chancellor ordered to place the matter before the Syndicate.
3. The matter of constitution of Board of studies in Public Administration (U.G & P.G) under the faculty of Humanities was considered by the Syndicate, vide paper 2nd above, and the same was approved, vide Minutes read 3rd above. The same was implemented vide paper read 4th above, but the list of members of the Board of Studies was not provided.
4. As per Statute 20 (2) and (3) of the Calicut University First Statutes 1976, the Board of Studies shall be constituted by the Syndicate and the members of the Boards of Studies other than ex-officio members shall be appointed by the Syndicate. Therefore the proposal for the selection of Board of Studies members in Public Administration (Single Board) was placed before the Syndicate, as per paper read 5th.
5. The Syndicate considered the matter again, as per the paper read (6) above, and resolved to entrust the matter with the subcommittee for reconstitution of the Board of Studies, already constituted vide U.O No 14072/2019/Admn dtd 04/10/2019. The same was implemented vide paper read (7) above.

6. The Sub-committee recommended to constitute the Board of Studies in Public Administration (Single Board) and the list of members was submitted to the Vice Chancellor.
7. As per the paper read (8) above, the Vice Chancellor's office forwarded the report of the sub-committee of the Syndicate, nominating Mr. Salim N as the Chairperson of the Board of Studies, as per the provisions under statute 26 chapter 3 of the Calicut University First Statutes, 1976 and this report was placed before the Syndicate, as per the paper read 9th above.
8. The Syndicate considered the report and resolved, vide paper read 10th above, to approve the same. Sanction has been accorded by the Vice Chancellor to implement the resolution of the Syndicate, vide ref. (11) above.
9. Orders are therefore issued to constitute the Board of Studies in Public Administration under the Faculty of Humanities, with the following members. The members of the Board shall hold office for a period of 3 years from the date of their entering into office as per the provisions under Calicut University Act 1975 clause 28 (3).
