ORDER

1. As per the paper read (1) above, Dr. Paul Pulikkan Visiting Professor, Chair for Christian Studies and Research, University of Calicut requested to complete the process of Constitution of the Board of studies in Christian Studies which was started in the year 2014. The process of Constitution of the Board of studies in Christian Studies was started in 2014 when the Syndicate meeting held on 03.07.2015 resolved, vide item No 2015.911* to constitute the Board of Studies for Christian studies with 11 members. Since the statute 23 in Chapter 3 of the Calicut University First Statute 1976, permits only 10 members in the Board, the Syndicate later referred it to the Standing committee on Courses and Research, to get it reduced to 10 Members, vide item no. 2015.1183* at its meeting held on 11.09.2015 and implemented vide U.O No.10183/GA-1-F2/2020 Admn dated 29.09.2015.
2. Since there was a delay in further developments, Dr. Paul Pulikkan requested, vide paper read 1st above, that the matter may be placed before the Standing Committee on Courses and Affiliation, and the constitution of the Board may be completed by the Syndicate as soon as possible. As per the orders of the Vice Chancellor, the matter was placed before the Syndicate, vide paper read 2nd above.
3. As per the minutes read 3rd above, the Syndicate at its meeting held on 20.03.2021 resolved to authorise the Vice-Chancellor to initiate action to constitute the Board of Studies in Christian Studies and to nominate the members to the same. As per paper read 4th, sanction was accorded by the Vice-Chancellor to implement the decision of the Syndicate.
4. Accordingly, the Vice Chancellor nominated Dr. Vincent P J as the Chairperson and the following members of the Board of Studies in Christian Studies. The members of the Board shall hold office for a period of 3 years from the date of their entering into office as per the provisions under Calicut University Act 1975 Chapter IV, clause 28 (3)
