ORDER

1. As per the Calicut University Act 1975, Chapter IV clause 28 (i) There shall be a Board of Studies attached to each subject of study in the University, provided however that post-graduate studies in each subject may have separate Board of Studies. (ii) The constitution and powers of the Board of Studies shall be prescribed by the Statutes, and (iii) Members of Boards of Studies shall hold office for a period of three years from the date of their entering into office. Hence, orders were issued to constitute a separate Board of Studies for each Integrated Courses, as per the paper read 1st above.
2. As per CUFS 1976 Chapter 3 statue 20(2), the Board of studies shall be constituted by the Syndicate. Accordingly, as per the paper read 2nd above, the matter of constitution of the Boards of Studies for Integrated courses and the nomination of members to the Boards of Studies, was placed before the Syndicate for consideration.
3. As per the paper read 3rd above, the meeting of the Syndicate held on 30.12.2021 authorised the Vice Chancellor to constitute Board of Studies for each Integrated courses and to nominate members to this Board of Studies.
4. As per paper read 4th above, sanction has been accorded by the Vice-Chancellor to implement the decision of the Syndicate and has ordered to constitute a Board of Studies for Integrated M.A Developmental Studies with the following members:
