**ORDER**

The term of the Board of Studies in Law(U.G), Law(P.G) under the Faculty of Law , Catering Science & Hotel Management(Single Board) and Food Technology(Single Board) under the Faculty of Science reconstituted vide paper read (1) above, expired on 10.02.2023. As per the Calicut University Act 1975 & Calicut University First Statutes 1976, Chapter 3, Clause 24 the Boards of Studies shall be reconstituted by the Syndicate once in three year. As per paper read as (2) above a Sub-Committee was constituted to study the matter of reconstitution of the term expired Boards of Studies under various Faculties based on the decision of the Syndicate held on 02.11.2022.

As per paper read as (3) above, Syndicate authorised the Vice Chancellor to reconstitute 5 Boards of Studies viz Board of Studies in (1)Law(UG) (2)Law(P.G) (3)Catering Science & Hotel Management (4)Food Technology and (5)Functional Hindi.
