Sub:- Election to the Academic Council under Section 24(l), (m), (p) & (r) - Publication of Electoral Roll of Principals, Teachers, Post Graduate Students of Affiliated Colleges and University departments - Reg.

As per paper read 1<sup>st</sup>above, Electoral Roll for the Various Constituencies (The Principals of Professional Colleges to elect five members from among themselves, The Principals of First Grade Colleges other than colleges of Oriental Languages to elect seven members from among themselves, The teachers of the subject of study from among the teachers of that subject) of the Academic Council has been published in the University Office and University Website on 27.10.2023. The Electoral Roll of the constituency of Full Time Post Graduate Students to elect one member from among themselves representing each faculty is published on 31.10.2023.

As per Statute 15 of the Calicut University First Statutes, 1975,"Corrections, alterations, etc., in electoral roll: It shall be competent for the Returning Officer to make any addition, correction alteration or deletion in any electoral roll, provided that the fact necessitating such correction or alteration or deletion is brought to his notice within 15 days after the publication of the electoral roll and that he is satisfied that such correction or alteration or deletion is necessary".

Hence, it is hereby request you to forward addition, correction alteration or deletion, if any, in respect of the electoral roll of Principals of Professional Colleges, Principals of First Grade Colleges and teachers of the subject of study from among the teachers within 15 days after 27.10.2023 to the Registrar and Returning Officer in the proforma.

You are also requested to forward the addition, correction alteration or deletion, if any, in respect of the electoral roll of Full Time Post Graduate Students within 15 days after 31.10.2023 to the Registrar and Returning Officer in the proforma.


The names of persons who are on the electoral body 60 days before the date of publication of the electoral roll alone shall be included in the electoral roll, and such persons alone shall be entitled to participate in the election, provided that any person who ceases to be a member of an electoral body before the date of issue of the ballot paper from the University Office shall not be entitled to participate in the election (Statute 14, Chapter 1, CUFS 1975).

The electoral roll of Principals of Professional Colleges, Principals of First Grade Colleges and teachers of the subject of study from among the teachers of that subject have already been published on 27.10.2023. Hence Principals/Teachers whose appointments are approved by the University or DCE on or before 27.08.2023 alone shall eligible to be added in the published electoral roll as per Statute 14&15, Chapter 1, CUFS 1975.

As the electoral roll of full-time post-graduate students of the faculty is published on 31.10.2023, full-time post-graduate students who took admission on or before 31.08.2023 are only eligible for addition to that published electoral roll as per Statute 14&15, Chapter 1, CUFS 1975. In the case of full-time post-graduate students, the date of admission taken which was given in the references cited as (2) and (3) above shall be corrected to read as on or before 31.08.2023.

Please treat this as election urgent.
