It is notified for the information of all concerned that **Second and Fourth Semester (CUCSS) MBA International Finance & MBA Health Care Management** (for affiliated colleges - 2016 scheme - 2017 & 2018 admissions) '**One Time Regular Supplementary Examinations', September 2023**, for the **chance exhausted and course completed candidates of affiliated colleges**, will be conducted by the University, as per the following schedule:

4. Semester wise Registration fee: **Rs.525/-** (To be paid in addition to the examination fee shown above).

7. Centre of Examination : **Seminar Hall, Tagore Nikethan, Calicut University Campus.**
8. Mode of Payment of Fee: Candidates should make the payment of fee through e-payment/e-chalan with SBI, Akshaya Centres and Friends Janasevana Kendra. No other mode of payment is acceptable.
