2	Location of Work	Thenhipalam, Calicut University Campus, Malappuram District
3	Estimated Cost of the Work	Rs.2,70,575/-
4	Brief description of work	The work include dismantling worn-out and disoriented tiles above the balance tank portion, re-fixing existing step tiles using 20 mm thick cement mortar (1:3) modified with SBR latex polymer, laying 22 mm thick chequered terrazzo tiles and 20 mm thick vitrified floor tiles, grouting with epoxy, and fixing handrails using S5 anchor fastener bolts, etc.

Tenders/ bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. Late tenders will not be accepted. A bid submission fee shall be remitted online during the time of bid submission.

The hard copies of certificates and documents, as detailed in clause 4.4 of Part-I Instructions to the Bidders, shall be submitted subsequently after online submission of bids in a separate cover by registered post/speed post before the date and time of opening of technical bid. Price Bid shall only be submitted through online. Details regarding remittance of Bid Submission Fee and Bid Security, Bid preparation and submission are mentioned in the bid document.

The bids shall be opened online at the *Office of the Executive Engineer (Civil), University of Calicut on 14.09.2026* at 11 AM by the Executive Engineer (Civil), in the presence of the Bidders / their representatives who wish to attend at the above address. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at sametime and place.

Online Tenders/ bids are to be accompanied with a preliminary agreement executed in prescribed format. Tenders/ bids received online without the details mentioned in clause 4.4 of Part-I Instructions to the Bidders will not be considered and shall be summarily rejected. **Payment shall be subject to availability of Funds.**
