Qualification:- The qualification for the said posts will be as per the UGC norms for Assistant Professors (PG with 55% aggregate in the relevant subject + NET/PhD).

Age limit as on 01.01.2021 : Below 40 years (Upper age limit prescribed will be relaxed in the case of OBC, SC/ST and differently abled candidates by 3 years, 5 years and 10 years respectively subject to the relevant provisions of KS&SSR.

Remuneration: The remuneration for the post of Assistant Professors on contract will be Rs.35000/- (Rupees thirty five Thousand only) per month (consolidated).

Nature of appointment: Contract Basis.

Term of Contract : One year from the date of joining.

Last date for applying online :19.06.2021.

Instructions for the candidates :

4. Candidates who fail to submit the documents on or before 19.06.2021 will not be considered for the interview.

5. The candidates who are found eligible after the verification of documents submitted will only be called for the interview.
