 - Percentage Certificate if the evaluation is in Grading System and there is no specific formula in the grade cards for conversion of grades to equivalent percentage.
 - Equivalency Certificate if the qualifying Degree is from a University outside Kerala.
 - NET/JRF/M.Phil/Ph. D. certificates.
 - Experience Certificate, if any.
 - Proof for Awards, Publications and Paper Presentations, if any.
 - Certificates to prove any other claims made in the application.
3. **Non NET/Ph.D candidates will be considered only in the absence of NET/Ph.D holders.**
4. The inclusion of names of the candidates in the list appended, is purely provisional. If any of the claims made in the application are found to be incorrect, or if the candidate is found to be ineligible for the post, at any further stages of recruitment process, the candidature is liable to be cancelled.
