ORDER

As per paper read as (1) above, Mr.lwin.K.A requested to grant equivalency to the programme BA (Honours) with Specialization in Public Administration under regular mode offered by Chhatrapati Shivaji Maharaj University (Private University) with BA Public Administration programme of the University of Calicut.

As per paper read as (2) above, the Steering Committee on CBCSS UG 2019 considered the matter of taking a common decision with regard to the granting of equivalency to U.G Honours programmes offered by State/Central/ Deemed/Private Universities with three year duration to the corresponding UG programmes (Three Year Duration) of the University of Calicut, and recommended to grant equivalency to U.G Honours programmes offered by other Universities (approved/recognised by UGC), subject to the Regulations on Recognition & Equivalency of Programmes and the following conditions :

- (i) Nomenclature shall be Honours.
- (ii) Duration of the Programme is the same or longer.
- (iii) Mode of Study should be Regular.
- (iv) Credit shall be at par with the credit of the University of Calicut.

As per paper read as (3) above, the Academic Council considered the recommendations of Steering Committee on CBCSS UG 2019 held on 11.07.2025 and resolved to approve the same.

Sanction has been accorded by the Vice Chancellor to implement the above resolution of the Academic Council.

Hence the Academic Council resolution **to grant equivalency to UG Honours programmes offered by State/Central/Deemed/Private Universities with corresponding UG programmes of University of Calicut**, subject to the Regulations on Recognition & Equivalency of Programmes and with the following conditions:

- (i) Nomenclature shall be Honours.
- (ii) Duration of the Programme is the same or longer.
- (iii) Mode of Study should be Regular.
- (iv) Credit shall be at par with the credit of the University of Calicut, **is thus implemented.**
